After completion of above aid work, there was some surplus amount and beneficiary families have paid back the amount to the trust; then it was decided to use this amount in the education of children of families of the community.

Loan assistance to the needy student has been started till they complete their education from the year 2002-03 with a view of "educated family is a prosperous family" and started providing interest-free loan assistance of Rs. 8000/- per year. Standards of fees and living standard both were on rise with time.

Therefore, Shree Mahavir Charitable Trust has organized an **event-1 "donation for education is a great donation"** in the year 2010.

Collective understanding of the society about importance of the education and a spirit that each and every children of entire Sthanakwasi Jain Community should have an education of at least a graduate level, donors have donated generously to the trust and trust has increased the amount of loan assistance.

But, this amount was also too low with time, so **event-2 "donation for education is a great donation"** organized in the year 2012, which was highly successful with cooperation of all the people. This success has given great boost to our enthusiasm.

As a result of it, trust has initiated loan assistance of Rs. 3,00,000/- per year for medical students and loan assistance of maximum Rs. 1,50,000/- per year for engineering and developmental courses like MBA. In addition to it, the trust has also initiated loan assistance of up to Rs. 25,000/- per year for students staying in hostels in other cities. This improved loan assistance has provided considerably relief to the students and their families.

In addition, many institutes also run vocational courses, this enables students to carry on the study with the job. We have implements loan assistance scheme for vocational courses like web-designing, software development, animation etc. Under this scheme, loan assistance is also provided for distance learning.

Result of std. 11th and 12th exam is very important for admission in good college for carrying out good course. Therefore, loan assistance of aggregate Rs. 1,00,000/- is also initiated for private tuition of both the standards and private tuition for JEE and NEET. Loan assistance of 30,000 is also provided for computer/laptop.

Loan assistance amount has been raised as follows in the schemes mentioned above.

1. Under higher education scheme and vocational study scheme, full amount up to Rs. 2,00,000/- and 50% of additional amount but maximum loan assistance of up to Rs. 4,00,000/- is provided.

2. With an objective of making families of community self-reliant maximum loan assistance of Rs. 1,50,000/- is provided for profession/business.

Loan of all the schemes described above is given entirely interest-free and repayment of loan assistance is also to be done in easy instalments.

The institute has given loan assistance of Rs. 31.56 crore to the 2799 beneficiaries to this date. About 500 students have completed their study and repaid the entire loan amount.
